Major additions to the collection in 2015 include: an iconic IBM 1401 system (1959), 1960s electronic components (800 lbs), manufacturing equipment from IBM microelectronics and successor companies, IBM 5114 computer system, 677 player piano rolls, 2014 Olympic bobsled, and collection of 75+ vintage Ansco cameras and related photographic equipment. All IBM equipment are on display at the Techworks! Vintage IBM Computing Center, built on a raised floor collected from IBM Plant # 1, Endicott, NY. A multi-year project to return an IBM 1403-N1 printer to operation reached a milestone in May 2015 - printing its first pages under the control of a 21st century printer controller built by TechWorks! team. All the above mentioned artifacts represent technical advances from New York's Southern Tier, meeting the Center's primary purpose, and will be preserved, operated as condition permits, and interpreted to inspire technical creativity in future generations.
